We've come a long way since 2006 when we opened our doors...or I should say trunk of the car, since that's where our first Director's office was located. We didn't have much when we began, but it was enough. We had Anne Mychalus, our first Executive Director, 10 trained mediators and a passion for wanting to make a difference in our community. We started out with the intention of providing professional conflict resolution services at no cost to the residents of our community, and that remains our primary and most important focus today. Through our first ten years, we've conducted more than 880 mediations, assisted more than 3,000 members of our community have the kind of intentional conversations that have enabled them to reach clarity on their needs, communicate effectively with one-another, and move forward in their lives.

But there's more! Mediation is one piece of the peace building puzzle. Another is offering organizations, schools, churches, businesses and agencies educational workshops on how to better handle conflict. We call our workshops "Rethinking Conflict" because we introduce participants to a different way to think about the disputes they encounter in their lives. Conflict is a normal human experience. How we think about it determines how we respond to it.

This work is not done alone. We have found great support with many community partners, too numerous to mention. Thank you for your support in partnering with us, referring people to us, providing moral and financial support, and welcoming us into your spaces. We couldn't have done it without you.

We look forward to the next decade of service to our Calvert community!
